- Would county consider alternative FBO at current location? Could someone else solve current problems w/o county subsidy? A: County is not subsidizing this effort. It's part of Airport Authority funding.

## Rebecca Burke, Q&A<sup>2</sup>

- There are new grant dollars in recent years.
- Will the market support two FBOs? Probably not.
- Goal: Be user friendly.
- The needs of the community need to come first.
